### **Discussion**

This report provides updates and informational items relative to the following:

#### A. CURRENT/UPCOMING PROJECTS & BOARD MEETING CALENDAR

**Projects** – Personnel Department staff are responsible for four primary functions for the City's Deferred Compensation Plan: communications, operations, administration, and governance. Following are updates of certain key projects:

#### Communication

• <u>3Q Newsletter & Statements:</u> The final newsletter and participant statements from Empower are expected to be mailed out at the end of October.

#### **Operations**

 <u>Participant Services</u>: Staff continues to assist participants with questions and issues related to the TPA transition, loan administration, distributions, contributions, special catch-up enrollment, and accrued leave deferrals.

#### Other Items

• NAGDCA Conference Update: The 2017 NAGDCA Annual Conference took place in Milwaukee, Wisconsin beginning September 24 and ending September 27, 2017. This year's conference focused on behavioral economics, benchmarking, and other topics intended to help plans improve participant outcomes. Presentations and interactive sessions provided forums for discussion among plan sponsors as well as service providers. The keynote speech was a presentation on behavioral economics by Dr. Bridgette Madrian who discussed the behavioral barriers that impede individuals from adequately saving for retirement, procrastination, complexity, and limited financial literacy. Speakers

also discussed the possibility of potential tax reform legislation as it relates to protecting public sector retirement plans. The closing speaker, Dr. Lowell Catlett, discussed the ways in which, over the last several decades, the world has progressed and changed for the better and how technology would impact retirement plan administration.
