#### Recommendation:

#### Discussion:

Following are updates on certain key items for the month of December 2017.

#### A. Communications

<u>Fourth Quarter 2017 Newsletter & Statements</u> - Voya's first quarterly newsletter will accompany the fourth quarter statements for the quarter ending December 31, 2017. Staff has finalized the newsletter and statements, and they will be mailed by Voya at the end of January.

#### **B. Legislative Update**

<u>Federal Tax Law Changes</u> - On December 22, 2017, President Donald Trump signed into law the 2017 Tax Cuts and Jobs Act (the Act). Before the final version of the Act was written, there was concern that the bill might impact Internal Revenue Code Section 457 plans by limiting pretax deferrals or requiring contributions above a certain level to be made in after-tax dollars (referred to as "Rothification"). Those provisions were not included in either the Senate or House original bills and were also not included in the final version that was signed into law. Provisions in the bill affecting retirement plans more generally were minimal. A rule permitting re-characterization of a conversion contribution to a Roth Individual Retirement Account (IRA) was repealed, meaning that individuals who convert pre-tax IRA dollars to Roth IRA dollars cannot subsequently reverse that conversion. In addition, for participants who separate from service with outstanding loans and fail to make payments, outstanding amounts of those loans deemed to have been distributed will have an extended date (until the due date for filing their tax return for that year) to contribute the loan balance to an IRA.
