- (10) Board Report 20-06: 2020 Resources Review and Annual Budget Adoption Update That the Board: (a) approve the following DCP Growth and Expense variable and Fee variable assumptions for use in projecting future DCP Reserve Fund balances: (1) DCP Assets Growth Rate - 7%; (2) Net Enrollment Growth Rate - 3%; (3) Annual Expenses Increase Factor - 2%; (4) Special Rates Increase Factor: Personnel - 115%; (5) Special Rates Increase Factor: City Attorney - 115%; (6) Stable Value Interest Rate - 2%; (7) Participant Fees: Annual Basis Point Charge - 0.09%; (8) Participant Fees: Annual Dollar Cap - \$115; and (b) approve for the quarter ending September 30, 2020, a reduction of the quarterly basis point fee assessment from 2.25 basis points to 1.125 basis points, and a reduction in the quarterly fee cap amount from \$28.75 to \$14.38.
