


## Pending Projects & Information Items:

- Hermes Creative Awards The City of Los Angeles Deferred Compensation Plan won a Gold medal for the "Premiere" Enrollment booklet and Honorable Mention for the Plan website. Hermes Creative Awards recognize outstanding work in the industry, while promoting the philanthropic nature of marketing and communication professionals. There were over 3,700 entries from throughout the United States and the world in the 2009 competition.
- Financial Strength of Great-West –Staff recently received a letter from Great-West President and CEO, Mitchell Graye, addressing the financial strength of Great-West Life & Annutiy Insurance Company (GWL&A). Attached is the letter for review.

- Board By-Laws This project continues to be under development and is tentatively scheduled for the Board's June meeting.

**Accrued Leave Activity** – Staff has compiled the following results of Accrued Leave enrollment for the month of April 2009. During the month of April, eleven participants elected to enroll in Accrued Leave and \$228,905 was contributed into the Plan from their Accrued Leave payouts.









