
Hardship Activity January'11

Distribution Reasons







Following are hardship activity results from January 2010 to January 2011:



Loan Activity – Staff has compiled the following results of new loans acquired for the month of January 2011. During the month of January, 387 participants elected to obtain a new loan and \$4,945,676 was withdrawn from the Plan from their loan payouts.



Deferral Tracking - Staff has compiled the following results of bi-weekly deferral cash flows for the month of January 2011 for the City of Los Angeles and Department of Water and Power. During the month of January, the City and Department of Water and Power deferred \$20,836,862 into the Deferred Compensation Plan. This compares to **\$22,739,779** in January 2010, or a reduction of **8.4%** year-over-year.
