




Accrued Leave Activity

Following are accrued leave activity results from January 2010 to November 2013:





Accrued Leave Deferral Amounts




Hardship Activity

Staff has compiled the following results of hardship processing with Great-West for the month of November 2013. During the month of November, 32 hardship cases were submitted to Great-West. There were 24 cases approved, 2 cases were cancelled or denied, and 5 cases were pending further documentation; additionally, there was one case that was approved by the Plan. The dollar amount for hardships withdrawn from the plan in November 2013 was approximately **\$171,803.**






Following are hardship activity results from January 2008 to November 2013:




Hardship Dollars Disbursed




Loan Activity

Staff has compiled the following results of new loans acquired by participants for the month of November 2013. During the month of November, 504 participants elected to obtain a new loan and \$5,876,856 was withdrawn from the Plan for their loan payouts.

Loan Activity








For Retirees or Terminated Employees

In October 2012, the Plan introduced the availability of loans for participants who are retired or otherwise separated from City service. Participants electing this option may pay back the amount borrowed from their account in monthly installments, either by check or by automated payment from their bank account. Additionally, employees who have active loans may, upon retirement or separation of service, request conversion to a retiree loan in order to continue payments rather than requesting a loan offset.

In November 2013, staff processed 7 new loan requests and 5 requests for loan conversion. To date, staff has processed a total of <u>244 requests for retiree loans</u> and 106 requests for conversion.




Deferral Tracking

Staff has compiled the following results of bi-weekly deferral cash flows for the month of November 2013 for the City of Los Angeles and Department of Water and Power (DWP). During the month of November, the City and DWP deferred \$13,034,986 into the Deferred Compensation Plan. This compares to \$12,471,479 in November 2012. which constitutes a **4.5% increase**, year-over-year.

YEAR-OVER-YEAR, BY PAY PERIOD




Roth Accounts

The Roth deferral option was made available to participants starting July 2011, with actual deferrals being made by August 2011.

For the month of November 2013, there were 101 new Roth accounts established. There are currently a total of 1,584 Roth accounts. This constitutes a 5.6% participation rate of the 28,340 employees contributing to the plan¹. The following chart on the next page illustrates the number of new Roth deferrals since August 2011.

Board Election Update

Two seats on the Board of Deferred Compensation Administration will be expiring on June 30, 2013: the LACERS active employee participant representative seat and the Fire and Police Pensions active employee participant representative seat. Staff has contacted the Office of the City Clerk – Election Division to coordinate the election, which will be scheduled for May 16, 2014. Nominating petitions will be available to potential candidates beginning March 21, 2014, to be turned in by April 4, 2014.

The election will be announced to participants via the 4th quarter newsletter, which will be mailed to participants during the last week of January 2014. Staff will also provide updates to the Board's website page regarding the Board Elections (located at http://per.lacity.org/DeferredComp/ElectionsPage.htm), post bulletins on the new participant website, and send out a Notification of Election in early March 2014.

Board Officer Designations – January 2014

Per the City Administrative Code, the Board is required to designate a Chairperson and Vice-Chairperson at the January meeting of every even-numbered year, and per the Board's Bylaws, the Board also designates its First, Second and Third Provisional Chairs at this meeting as well. Officer designations will therefore be placed as an item on the Board's January 2014 meeting agenda.
