



# HARDSHIP ACTIVITY

Staff has compiled the following results of hardship processing with Great-West for the month of October 2014. During the month of October, 30 hardship cases were submitted to Great-West. There were 24 cases approved, 3 cases pending additional information, and 3 cases denied. The dollar amount for hardships withdrawn from the plan in October 2014 was approximately **\$168,245**.








# LOAN ACTIVITY

Staff has compiled the following results of new loans acquired by participants for the month of October 2014. During the month of October, 581 participants elected to obtain a new loan and **\$7,607,036** was withdrawn from the Plan for their loan payouts.





#### For Retirees or Terminated Employees


In October 2012, the Plan introduced the availability of loans for participants who are retired or otherwise separated from City service. Participants electing this option may pay back the amount borrowed from their account in monthly installments, either by check or by automated payment from their bank account. Additionally, employees who have active loans may, upon retirement or separation of service, request conversion to a retiree loan in order to continue payments rather than requesting a loan offset.

In October 2014, staff processed 22 new loan requests and 19 requests for loan conversion. To date, staff has processed a total of <u>447 requests for retiree loans</u> and <u>266 requests for conversion</u>.



### **DEFERRAL TRACKING**


Staff has compiled the following results of bi-weekly deferral cash flows for the month of September 2014 for the City of Los Angeles and Department of Water and Power (DWP). During the month of October, the City and DWP deferred **\$22,175,636** into the Deferred Compensation Plan. This compares to **\$20,826,807** in 2013 for the same pay periods, which constitutes a **6.5% increase**, year-over-year.



# **ROTH CONTRIBUTIONS**

The Roth deferral option was made available to participants starting July 2011, with actual deferrals being made by August 2011.

At October 2014 end, there were **3,224** participants with a Roth balance. This figure represents approximately **7.9%**<sup>1</sup> of all participants with a balance.



There were a total of 85 new Roth accounts added in October 2014:

### **ANNUAL LIMITS UPDATE**

The IRS announced that limits would be increasing in 2015. The regular limit is increased from \$17,500 to \$18,000; the over 50 limit is increased from \$23,000 to \$24,000; and the special catch-up limit is increased from \$34,000 to \$35,000.
