Recommendation:

That the Board of Deferred Compensation Administration receive and file staff's update on Plan projects and activities during March 2015.

Discussion

This report provides updates and informational items relative to the following:

A. CURRENT/UPCOMING PROJECTS & BOARD MEETING CALENDAR

Projects – Personnel Department staff are responsible for four primary functions relative to executing the City's Deferred Compensation Plan: communications, operations, administration, and governance. Below are some key projects that staff have been working on.

Communications

- 2015 Fund Changes
 - Part 1 of the fund changes was completed on March 20, 2015, when the DCP Small-Cap Fund was created and the underlying allocations to the DCP Mid-Cap were updated.
 - The final step of the 2015 changes is scheduled to occur on June 26, 2015, and will include the creation of the DCP International Fund and an update to the underlying funds of the DCP Small-Cap Fund (the current contract with State Street is expiring June 2015 and the Investments Committee has selected Vanguard as the new manager of the underlying passive component of this fund). Staff updated the custom web page dedicated to the 2015 Fund Changes and created a new fund fact sheet for the DCP International Fund. Communication of the details regarding the change is included in the 1st Quarter 2015 newsletter, to be mailed to participants in late April. Additionally, a letter targeted to those with an elective deferral to or assets invested in either the Deutsche or Fidelity funds was prepared and mailed.
- *Newsletter:* Staff finalized the 1st Quarter 2015 newsletter for print and distribution.

Operations

- FDIC-Insured Savings Account
 - *Rate Correction:* Staff was recently made aware of an incorrect rate applied to the FDIC-Insured Savings Account, which affected 4th Quarter 2014 and 1st Quarter 2015 performance. More detailed information about this correction is included in a Board report on this same agenda.
 - Bank of the West: Bank of the West is one of the underlying providers of the FDIC-Insured Savings Account. Bank of the West recently notified the Plan that it became aware of fraudulent activity on another 457 plan account it services. Given this, staff is working with Bank of the West and the recordkeeper to ensure appropriate safeguards are in place for the Plan's account and that only approved transactions are authorized on the account.
- Auto-Enrollment Program: Staff is working with Plan counsel, with additional review from the Plan's tax counsel, and the recordkeeper to clarify operational details and language nuances as the applicable Plan Document language is formalized.
- Site Visit: Staff is scheduled to conduct a site visit to the Empower home office on April 16-17, 2015 to view operations and discuss opportunities for improvement to work processes.

Administration

- Procurements & Contracts
 - Staff received responses from three firms for the consulting services RFP: Mercer, RVK, and Segal. Mercer and Segal have submitted proposals for all three consulting areas: plan design and administration, investments, and communications. RVK submitted for plan design and administration and investments. Staff will be coordinating performance examinations and is working to evaluate responses. Selection recommendations from staff will be provided to the Board at the May meeting.
 - Staff is working to finalize the contract amendment language for Mercer Investments Consulting.
- *Metrics:* Staff has been compiling data to be used for Plan benchmarking purposes as well as for departmental metrics purposes. Staff will be presenting the first draft of the revamped quarterly report to the Board in May.
- *CAP Rate:* Staff continues to meet with Controller's Office and the Administrative Services Division of the Personnel Department to address the Cost Allocation Plan (CAP) rates attributed to the Deferred Compensation Plan. Staff believes that adjustments to the current CAP rates are needed. No salary reimbursements will be processed until the CAP rates are fully reviewed and confirmed. Staff anticipates having a recommendation to address the CAP rates at an upcoming Board meeting.

Governance

 Board Elections: Petitions for the active DWP employees or retired/separated from City service Board seats were available beginning March 27, 2015 and were due by April 10, 2015. The City Clerk – Elections Division, which is administering this election, has indicated that the following individuals have qualified as candidates for this election:
