Recommendation:

Discussion

This report provides updates and informational items relative to the following:

A. CURRENT/UPCOMING PROJECTS & BOARD MEETING CALENDAR

Projects – Personnel Department staff are responsible for four primary functions relative to executing the City's Deferred Compensation Plan: communications, operations, administration, and governance. Below are some key projects that staff have been working on:

Communications

- Newsletter 2nd Quarter 2015: Staff reviewed and drafted content for the upcoming newsletter. The key topic will address the importance of updating beneficiary information, and will include mention of the Plan's action plan to include beneficiary names on participant statements starting in 3rd Quarter (to mail in late October).
- Targeted Enrollment Initiative: Staff developed initial drafts of the postcard that will be sent to targeted Department of Transportation (DOT) employees. This is part of the effort to increase DCP participation within this department. Staff is additionally reaching out to different area contacts to set up meeting dates and locations.

Operations

• 2015 Fund Change: The final step of the 2015 changes is scheduled to occur on June 26, 2015, and will include the creation of the DCP International Fund and an update to the underlying funds of the DCP Small-Cap. As part of the implementation timeline, the Fidelity Diversified International Fund was closed to new contributions and assets as of May 22, 2015. Staff is currently ensuring that all operational details have been addressed with Empower Retirement and the investment managers involved in the transition. Participants have received direct communications if invested in one of the International Funds, bulletins have been posted to the website, and information was sent out previously in the 1st Quarter newsletter (which was mailed in April).

 Auto-Enrollment Program: Staff has finalized the recommended revisions to the Plan Document, pending the Board's review and approval. Staff will now focus on developing a finalized operational workflow and will be scheduling discussions with the Controller's Office and DWP Payroll Office for programming implementation.

Administration

- Procurements: Staff is preparing for the procurement of a third-party administrator (TPA) for the Deferred Compensation Plan and the Pension Savings Plan. Staff will provide the Board with an overview of what the procurement preparation process will entail and other related information at the July Board meeting.
- Contracts: Staff has prepared drafts of the Stable Value investment management services (Galliard) and the Plan's consulting services (Mercer and Segal) contracts and is working with the respective vendors to finalize the agreements.
- Metrics: Staff has been compiling data to be used for Plan benchmarking purposes as well as for departmental metrics purposes. Staff and Empower Retirement have been able to refine Plan enrollment data and have been working to report on the correlation between local representative outreach efforts and actual enrollments. Staff worked with Empower Retirement to develop a regular monthly report that will allow the Plan to identify new enrollments by department and month.
- CAP Rate: Staff continues to meet with and further discussions with the Controller's
 Office and the Administrative Services Division of the Personnel Department to
 address the high Cost Allocation Plan (CAP) rates attributed to the Deferred
 Compensation Plan. No salary reimbursements will be processed until the CAP
 rates are fully reviewed and confirmed. Staff anticipates having a recommendation
 to address the CAP rates at an upcoming Board meeting.

Governance

• Board Elections: Election Day was on May 22, 2015; further discussion is included in a separate Board report.

A summary of all completed and upcoming projects for Division staff is provided as Attachment A.

Meeting Calendar – Staff maintains a calendar of upcoming Board meetings and proposed topics. This calendar includes the annual meeting plan and will be refined and updated as the Board meets and objectives/assignments are refined for the coming year. The current calendar is provided as Attachment B.
