Discussion:

Below are the Deferred Compensation Plan (DCP) project and activity updates for September and October 2023:

A. Operations and Project Updates

Human Resources & Payroll (HRP) Project – A decision was made to delay the HRP
Project Phase 2 go-live date from December 2023 to June 2024. The decision to delay
the Phase 2 go-live date was made to allow more time for comprehensive system testing
and employee training. Staff will provide updates as any new timelines are revised.
Currently, staff continues its efforts in end-to-end testing and parallel testing.


B. Communications Updates

• Third Quarter 2023 Statements and October 2023 Newsletter – DCP participant statements for the third quarter of 2023 (three-month period beginning July 1, 2023 and ending September 30, 2023) and the October 2023 DCP Newsletter were emailed to participants who elected electronic delivery on October 11, 2023. Participants who opted for mailers were sent statements and DCP Newsletters on October 16, 2023. Historical newsletters are posted online to the website at LA457.com/newsletters, and historical fund performances are posted online to the website at LA457.com/fund-performance.

Staff was notified that due to a system-wide error that affected multiple plan sponsors, some participants who elected e-delivery did not receive the automated email notification on October 11 2023, that the statements and newsletters were available. Additionally, some participants who elected e-delivery would also be receiving a paper statement. While the system error resulted in a delay in printing and delivery of paper statements, it did not affect the accessibility of the statements online.

Staff worked with Voya to immediately communicate the error to participants in several ways. Pop- ups were created on LA457.com and on Participant Web that explains the situation, and can be seen below. The delayed statements were mailed out on October 24, 2023 to the remaining participants. Lastly, an email was sent on October 25, 2023 to all e-delivery participants that did not receive the original email notification.




