Board of Deferred Compensation

Discussion:

Below are the Deferred Compensation Plan (DCP) project and activity updates for December 2023:

- A. Operations and Project Updates
 - <u>Required Minimum Distribution (RMD) Updates</u> On December 15, 2023, participants who were required to receive their 2023 RMD were sent their automatic distributions to satisfy the requirement. There were a total of twelve (12) participants who did not have enough funds in their Core Accounts for the automatic distribution. These participants were contacted by a Local Retirement Counselor and sent a letter notifying them of their need to transfer funds from their Self-Directed Brokerage Account to their Core Accounts to fulfill the RMD.

Additionally, in compliance with SECURE 2.0, Voya confirmed that their systems are updated so that RMDs calculated for tax years after December 31, 2023 will only consider non-Roth amounts during the participant's lifetime. Also, for participant deaths occurring after December 31, 2023, beneficiary accounts for surviving spouses may now defer their RMD until the employee would have achieved RMD age, compared to when the surviving spouse would have achieved RMD age.

 <u>Department of Water and Power (DWP) Human Resources and Payroll Update</u> – DWP will be undertaking a Human Resources and Payroll (HRP) conversion process and is also migrating to Workday. DWP's implementation schedule is provided below and will run concurrently with the City's HRP transition until the City's Go-Live date in June 2024. DWP's Go-Live date will be December 27, 2024.



B. Communications Updates

End-of-Year Checklist Campaign – The DCP launched a campaign to remind participants (both active and retired with a balance) of important end-of-year deadlines for Roth In-Plan Conversions and contribution changes, along with notification that the 2024 annual limits had changed. A total of 38,488 emails were sent. The campaign also included reminders for participants to secure and register their online accounts and update their beneficiary elections.  <u>National Retirement Security Month (NRSM) Wrap-Up Email</u> – To close out the NRSM Campaign, staff launched an email campaign to encourage those who interacted with the campaign but were not yet enrolled to join the DCP. The email thanked them for their interest in NRSM and encouraged them to join via a new promotional video highlighting the benefits and features of the plan. • <u>Voya Local Counselor Survey Results</u> – After scheduled appointments with a Voya Local Counselor, participants are sent an automated, voluntary survey to rate the service

they received, overall satisfaction with the DCP, likelihood of recommending the DCP towards others, and other general comments and feedback. The quarterly results of the survey are provided to the Board in **Attachment A**.






Participant Survey Results regarding Voya Local Representatives Service




Overall Satisfaction with the DCP
