### **Discussion:**

Below are the Deferred Compensation Plan (DCP) project and activity updates for February and March 2024:

## A. Operations and Project Updates

 <u>2024 Board Election</u> – The election for the Active Participant Water and Power Employees' Retirement Plan (WPERP) Representative seat and Retired and Separated Participant Representative seat is underway for the May 10, 2024 election day. The election calendar, election notification, and notice of election are provided in Attachment A. Following are the candidates that the Office of the City Clerk - Election Division (Election Division) have certified to be placed on the ballot:

• **Payroll File Errors** – Biweekly, a payroll changes file is generated by Voya, which transmits new and changed deferral and loan amounts to the DWP or City (non-DWP) payroll system. For the March 22, 2024 payroll changes files generated by Voya that were transmitted for processing on the April 3, 2024 paycheck, several errors occurred:

- (1) <u>File transmission errors</u>: The DWP payroll changes file was incorrectly formatted and missing two columns of data, which caused it to error in the DWP payroll system on March 25th, which was a City holiday. Voya corrected the file on March 26th and transmitted a revised file. Additionally, the City's payroll file was not immediately available for download and was received on Tuesday, March 26th (the file usually generates before Monday morning to be loaded into the City's system on the first day of the payroll processing window).
- (2) File content errors:
  - (a) Inclusion of erroneous amounts. Voya indicated that an error occurred in its programming/work process that caused 16 participants to have erroneous contribution amounts deducted from their April 3rd paychecks. Staff has communicated with the affected participants, issued applicable refunds, and/or have set up agreements to make up any missed contribution amounts.
  - (b) New or changed amounts not transmitted. During the weekend of March 16th, staff previously reported that Voya would be rolling out a platform enhancement (meant to improve back-end recordkeeping services) and a new front-facing dashboard for the participant website. For the payroll changes file that was sent to the City on March 22nd, this encompassed changes submitted by participants within an approximate two week date range of March 11-22. Vova indicated the first week of changes was processed in the previous version of the platform while the second week of changes was processed after the enhancement was implemented. Voya indicated the changes processed in the first week were not carried over correctly and as such, not included on the file. Voya local retirement counselors are directly contacting the participants where a significant amount was deducted that was in addition to what was requested to coordinate timely refunds. For the full population of participants affected, a notification will be sent to indicate the error and instructions and options for correction.

For the files transmitted for processing on the April 17th paycheck, Voya provided the values for the April 17th paycheck elections as well as corrections for the April 3rd paycheck.

- <u>Required Minimum Distribution (RMD) Automated Distributions</u> Participants attaining age 73 in 2023 and have also retired or otherwise separated from City service were required to receive their first RMDs by April 1, 2024. Voya processed automatic distributions for eight (8) participants falling into this category.
- <u>Participant Website Outage</u> On March 27, 2024, at approximately 12:00 p.m. Pacific Time (PT), staff discovered that Voya's Participant Website was experiencing an outage and alerted Voya. Subsequently, Voya indicated that the outage impacted the Participant Website, Plan Sponsorweb, and the Call Center. Staff immediately posted a notice on the website to inform participants of the outage, and directed them to contact a Local Retirement Counselor. At approximately 3:00 p.m. PT, Voya informed staff that the situation had been resolved.



## **B.** Communications Updates

DCP + Pension Campaign - In order to partnership promote greater and collaboration with the three City pension plans (WPERP, LAFPP, and LACERS), staff developed a campaign to encourage active and eligible employees to view the new DCP promotional video, learn more about the DCP, and referred participants to their applicable pension plan website. Custom emails and postcards were distributed to employees of each respective pension plan. The DCP video gained 1,154 new views since the promotion was launched.



• <u>Money Matters Zoom Virtual Meetings</u> – Money Matters sessions are held on the third Wednesday of each month from 12:00 p.m. to 1:00 p.m. Sessions are advertised through the DCP website, the Personnel Department's monthly Citywide newsletter, social media, and other communications content when timely. 

Each candidate, along with up to two (2) observers may observe the tally in-person or via Zoom by emailing <u>Clerk.ElectionAdmin@lacity.org</u> no later than **Tuesday, May 7, 2024**, at **5:00 p.m.** 

The candidate who receives the highest number of votes cast will be declared the winner of the election.
