Recommendation:

That the Board of Deferred Compensation Administration receive and file the following information regarding upcoming elections for the Board of Deferred Compensation Administration.

Discussion:

Following is an update regarding the upcoming elections for the DWP and Retired Participant Representative seats on the Board of Deferred Compensation Administration. Petitions for these seats were made available at the Employee Benefits Division from March 20 to April 3. Two individuals requested and submitted nominating petitions (one for each seat). In order to qualify, candidates for the DWP Participant Representative seat were required to obtain a minimum of 100 and not more than 200 signatures from their respective constituencies. Candidates for the Retired Participant Representative seat were required to obtain a minimum of 10 and not more than 20 signatures from their respective constituencies.

Staff is currently working on the creation of the Official Notice of Election, which will be submitted to the City Clerk and posted on April 17, 2009. The Notice will include the names of individuals who have qualified to run, the election date, a sample ballot, and rules concerning participants' eligibility to vote. Staff is also in the process of obtaining the official mailing lists that the City Clerk will use to send the ballots on April 24, 2009. Ballots must be returned by May 8, 2009. The Board will receive the official elections results from the City Clerk by May 22, 2009.
