


#### **Activity Reports:**

Counter Activity Employee Benefits Division – Staff has compiled the following results of Counter Activity flow for the months of October and November 2010. During the months of October and November, 377 participants visited the Employee Benefits Division to discuss their Deferred Compensation accounts with the Great-West representatives and/or staff. Accrued Leave Activity – Staff has compiled the following results of Accrued Leave enrollment for the months of October and November 2010. During the months of






**Hardship Activity** – Staff has compiled the following results of hardship processing with Great-West for the months of October and November 2010. During the month of October, fifty-two hardship cases were submitted to Great-West. Forty-five cases were approved, three denied, and four were pending further documentation. During the month of November, thirty-five hardship cases were submitted to Great-West. Thirty cases were approved, two denied, and three were pending further documentation.


### **Hardship Activity October '10**




#### **Distribution Reasons**




## Hardship Activity November'10





**Loan Activity** – Staff compiled has the following results of new loans acquired for the months of October and November 2010. During the month of October, 427 participants elected to obtain a new loan and \$4,673,562 was withdrawn from the Plan from their loan payouts. During the month of November, 467 participants elected to obtain a new loan and \$4,920,994 was withdrawn from the Plan from their loan payouts.



**Deferral Tracking** - Staff has compiled the following results of bi-weekly deferral cash flows for the months of October and November 2010 for the City of Los Angeles and Department of Water and Power. During the month of October, the City and Department of Water and Power deferred \$13,065,817 into the Deferred Compensation Plan. This compares to **\$14,958,865** in October 2009, or a reduction of **12.7%** year-over-year. During the month of November, the City and Department of Water and Power deferred \$12,699,741 into the Deferred Compensation Plan. This compares to **\$14,564,846** in November 2009, or a reduction of **12.8%** year-over-year.
