




## Activity Reports:

Counter Activity Employee Benefits Division - Staff has compiled the following results of Counter Activity flow for the month of December 2010. During the month of December, 199 participants visited the Employee Benefits Division to discuss their Deferred Compensation accounts with the Great-West representatives and/or staff. 
Accrued Leave Activity – Staff has compiled the following results of Accrued Leave enrollment for the month of December 2010. During the month of December, eleven participants elected to enroll in Accrued Leave and \$212,762 was contributed into the Plan from their Accrued Leave payouts. 


**Hardship Activity** – Staff has compiled the following results of hardship processing with Great-West for the month of December 2010. During the month of December, forty


hardship cases were submitted to Great-West. Thirty-four cases were approved, two denied, and four were pending further documentation.



**Loan Activity** – Staff has compiled the following results of new loans acquired for the month of December 2010. During the month of December, 467 participants elected to obtain a new loan and \$5,132,964 was withdrawn from the Plan from their loan payouts.



**Deferral Tracking** - Staff has compiled the following results of bi-weekly deferral cash flows for the month of December 2010 for the City of Los Angeles and Department of Water and Power. During the month of December, the City and Department of Water and Power deferred \$11,493,516 into the Deferred Compensation Plan. This compares to **\$12,771,704** in December 2009, or a reduction of **10.1%** year-over-year.
