## Recommendation:

That the Board of Deferred Compensation direct staff to provide quarterly reports to the Board advising of plan contracts, types of services and tentative dates of RFP initiation in order to keep Board members and staff aware of upcoming RFP processes and comply with the Plan's vendor communication policy.

## Background:

At the Board's February 15, 2011 meeting, during a discussion of the proposed bylaws a Board member inquired how the Board would be aware of the contracting schedule of plan services in order to be mindful of the proposed 12 month vendor communication policy. In summary, the proposed bylaws prohibit Board members and staff from meeting privately with employees, representatives or registered lobbyists of any actual or potential respondents in the 12 months prior to a scheduled initiation of a procurement process up to the award of the contract. Staff recommends providing a quarterly report to the Board listing the plan contracts, types of services, and tentative dates of a Request for Proposal (RFP) initiation in order to assist in keeping the Board members and staff aware of upcoming RFP processes and comply with the vendor communication policy.
