


Counter Activity Employee Benefits Division




Accrued Leave Activity

Staff has compiled the following results of Accrued Leave enrollment for the month of November 2011. During the month of November, 16 participants elected to enroll in Accrued Leave and \$346,641 was contributed into the Plan from their Accrued Leave payouts.



Following are accrued leave activity results from November 2010 to November 2011:




Hardship Activity

Staff has compiled the following results of hardship processing with Great-West for the month of November 2011. During the month of November, 52 hardship cases were submitted to Great-West. Forty-four cases were approved, one was denied, and seven were pending further documentation.

Additionally, the Board had asked that the number of cases referred to staff by Great-West, upon denial by Great-West on the basis of income loss over a year, be included in the staff reports. As requested, there was one case that was referred and approved by staff, which was discussed at the November 15, 2011 Board meeting. The Board also requested the dollar amount for hardships approved be included, which staff has included: for November 2011, a total of \$318,706 was withdrawn from the Plan for hardship requests.




Staff has compiled long-term hardship activity results since the reassignment of hardship processing to Great-West in 2008. Following are hardship activity results from January 2008 to October 2011:




Loan Activity

Staff has compiled the following results of new loans acquired for the month of November 2011. During the month of November, 484 participants elected to obtain a new loan and \$4,503,160 was withdrawn from the Plan for their loan payouts.




Deferral Tracking

Staff has compiled the following results of bi-weekly deferral cash flows for the month of November 2011 for the City of Los Angeles and Department of Water and Power. During the month of November, the City and Department of Water and Power deferred **\$18,808,174** into the Deferred Compensation Plan. This compares to **\$19,294,551** in November 2010, or a decrease of **2.52%** year-over-year.



Roth Accounts

Since deferrals for the Roth option began in August 2011, there have been 622 new Roth accounts established. This constitutes a 2.16% participation rate of the 28,855 employees contributing to the plan¹. The chart below illustrates the number of new Roth deferral accounts since August.
