Recommendation:

Discussion

This report provides updates and informational items relative to the following:

A. CURRENT/UPCOMING PROJECTS & BOARD MEETING CALENDAR

Projects – Personnel Department staff are responsible for four primary functions relative to executing the City's Deferred Compensation Plan: communications, operations, administration, and governance. Below are certain key projects that staff have been working on (outside of the projects discussed in separate accompanying reports):

Communications

- National Retirement Security Week 2015: Staff is concluding its work on the various components of this campaign, which include:
 - ✓ Proclamation signed by the Mayor
 - ✓ Development of short video
 - ✓ Development of microsite for the campaign
 - ✓ Postcard and mailing to retirees
 - ✓ E-mail and online notices to all Plan participants, including article in 3Q newsletter to mail shortly
 - ✓ Three "Time Portal" Quizzes (one for actives, for retirees, and one "past time" portal quiz for either demographic)
- DOT Targeted Enrollment Initiative: Empower local representatives conducted two Plan informational meetings and coordinated four table service sessions at DOT-affiliated locations in support of the targeted enrollment campaign through the month of September. An initial review indicates that results are positive and that participation rates have increased. Staff will report the refined results of this campaign at the November Board meeting to provide overall enrollment numbers through October.

Operations

- Web Security Passcodes: The Plan launched an enhanced alphanumeric account passcode feature, which is an option for all current accounts and mandatory for new accounts as of September 20, 2015. Currently, participants access their online accounts with a numeric PIN. Participants will be notified of this new feature in the 3Q newsletter to mail in late October. Staff is reviewing the question of whether this feature should be mandatory for all current accounts as well.
- *In-Plan Roth Conversion:* This feature will be turned on for participants at the end of October. Staff has prepared the internal work process documents and form samples. The option is advertised in the 3Q newsletter, and a web banner with an informational flyer will be posted on the participant site.

Administration

- DROP Mass Exit: Staff met with Los Angeles Fire and Police Pensions (LAFPP) on September 29 to discuss the needs of a large group of sworn officers required to exit the DROP program by July 2016. Staff will develop an enhanced schedule of DROP seminars and will coordinate collaborative efforts with LAFPP. Staff will also review methods to enhance communications to the sworn population, including DROP members.
- Contracts: Updates are indicated in another Board report under this same agenda.
- *Metrics:* Staff continues its work on identifying and tracking Plan data related to its efforts for the Targeted Enrollment Initiative and other general metrics reporting efforts (see related Board report and presentation).
- Cost Allocation Plan (CAP) Rate: A report on this will be provided at the Board's November meeting.

A summary of all completed and upcoming projects for Division staff is provided as Attachment A.

Meeting Calendar – Staff maintains a calendar of upcoming Board meetings and proposed topics. This calendar includes the annual meeting plan and will be refined and updated as the Board meets and objectives/assignments are refined for the coming year.
