











Distribution Reasons



Staff has compiled long-term hardship activity results since the reassignment of hardship processing to Great-West in 2008. Following are hardship activity results from January 2008 to July 2011:




Loan Activity – Staff has compiled the following results of new loans acquired for the month of July 2011. During the month of July, 484 participants elected to obtain a new loan and \$5,121,322 was withdrawn from the Plan for their loan payouts.



Deferral Tracking - Staff has compiled the following results of bi-weekly deferral cash flows for the month of July 2011 for the City of Los Angeles and Department of Water

and Power. During the month of July, the City and Department of Water and Power deferred **\$14,388,555** into the Deferred Compensation Plan. This compares to **\$13,891,134** in July 2010, or an increase of **0.4%** year-over-year.
