


Activity Reports:


Plan from their Accrued Leave payouts. Following are accrued leave activity results from September 2009 to September 2010:












Loan Activity Staff has compiled the following results of new loans acquired the for month of September 2010. During the month of September, 487 participants elected to obtain a new loan and \$5,647,974 was withdrawn from the Plan from their loan payouts.



Deferral Tracking - Staff has compiled the following results of bi-weekly deferral cash flows for the month of September 2010 for the City of Los Angeles and Department of Water and Power. During the month of September, the City and Department of Water and Power deferred \$13,199,572 into the Deferred Compensation Plan. This compares to **\$15,114,606** in September 2009, or a reduction of **12.7%** year-over-year.
