#### **Recommendation:**

That the Board of Deferred Compensation Administration receive and file staff's update on Plan projects and activities during May & June 2016.

#### **Discussion**

This report provides updates and informational items relative to the following:

#### A. CURRENT/UPCOMING PROJECTS & BOARD MEETING CALENDAR

**Projects** – Personnel Department staff are responsible for four primary functions relative to executing the City's Deferred Compensation Plan: communications, operations, administration, and governance. Below are certain key projects that staff have been working on:

#### **Communications**

- 2Q Newsletter & Statements: Staff and Empower are in the process of finalizing newsletter content. The newsletter and statements are expected to mail at the end of July.
- New Employee Welcome Packet: Staff requested and received quotes from Empower regarding the cost of printing and assembling Plan enrollment packets for new City employees. Staff submitted its revisions of the marketing materials that are to be included in the packets and are awaiting their finalization from Empower.
- Targeted E-mail Beneficiary Campaign: Empower has offered to coordinate a pilot targeted email campaign related to updating beneficiary designations. Empower's email address is currently "white-listed" with the City email system (so City email recipients will not automatically reject the email as spam). This email will be directed to participants that do not have a beneficiary designated with the Plan, but have previously provided an email address. Staff has completed their review of Empower's e-mail message and design. Pending minor revisions, the e-mail will be sent out shortly.
- Retirement Income Replacement Calculator: Staff has approved a revision/update to the functionality of the calculator to account for Los Angeles City Employees' Retirement System (LACERS) Tier 3 as well as Water & Power

- Employees' Retirement Plan's (WPERP) Tier 2 employees. Staff will be granted access to the calculator's test environment shortly. In the absence of any issues and/or delays, the updated calculator is expected to go live by the end of July.
- National Retirement Security Week (NRSW) 2016: Staff is creating a marketing proposal and strategy for this year's campaign and anticipates presenting an action plan at the Board's August Meeting. NRSW this year is officially October 17-21, 2016.

#### **Operations**

 Participant Services: Staff continues to assist participants with questions and issues related to loan administration, distributions, contributions, special catch-up enrollment, and accrued leave deferrals.

#### Administration

A summary of all completed and upcoming projects for Division staff is provided as Attachment A.

**Meeting Calendar** – Staff maintains a calendar of upcoming Board meetings and proposed topics. This calendar includes the annual meeting plan and will be refined and updated as the Board meets and objectives/assignments are refined for the coming year. The current calendar is provided as Attachment B.

#### **B. STAFFING AND COMMITTEE ASSIGNMENTS**

Staffing Summary/Updates - The Employee Benefits Division has two Senior II Personnel Analyst positions: one is primarily responsible for oversight of the City's Civilian L.A. Well Benefits program, and the other for the Deferred Compensation Plan and Commute Options/Parking sections. The latter position is vacant, and the former position is pending the retirement of the incumbent, Ana Chavez, in 2017. Once her duties have been transitioned to her successor over the coming month, the Employee Benefits Division will be reassigning Ms. Chavez to provide oversight to the Deferred Compensation Plan until her retirement in 2017. Ms. Chavez has over 36 years of service with the City. She has been working with the Employee Benefits Division since 2008. In addition to the administrative and operational oversight she has been providing for the City's benefits program, she also has extensive background in overseeing the exchange of information between the City's benefits Third-Party-Administrator (TPA) and the City's payroll system. As a result, Ms. Chavez has unique skills and experience that will greatly benefit the Deferred Compensation Plan, particularly in pushing forward the development of the automatic enrollment payroll functionality and addressing other matters that relate to data management for the Deferred Compensation Plan TPA.

**Angela Yin**, Management Assistant, began working with the Plan on July 11, 2016. She will assist with daily operations and administration tasks as well as oversee periodic governance projects for the Plan.
