#### Recommendation:

#### **Discussion**

This report provides updates and informational items relative to the following:

### A. CURRENT/UPCOMING PROJECTS & BOARD MEETING CALENDAR

**Projects** – Personnel Department staff are responsible for four primary functions relative to executing the City's Deferred Compensation Plan: communications, operations, administration, and governance. Below are certain key projects that staff have been working on:

#### Communications

- 4Q Newsletter & Statements: The 4<sup>th</sup> quarter 2015 newsletter and statements were mailed and posted to online accounts at the end of January.
- Annual Review of Print Materials: Staff and Empower conducted a year-end review of communications projects, along with prioritizing 2016 annual compliance updates that will be needed for the Plan's materials.

#### Operations

- Fire & Police Pensions DROP Exit Meetings: Staff assisted with reviewing and approving a high volume of DROP exit paperwork. Staff or Empower representatives were present for approximately six sessions held in January at the Fire & Police Pensions office.
- *Distribution of 1099-R:* Empower has mailed out copies of 1099-R forms, if applicable. Staff has been assisting participants in obtaining copies or otherwise answering questions related to these documents.
- *Participant Services:* Staff continues to assist participants with questions and issues related to loan defaults, minimum required distributions, special catch-up enrollment, and contribution scheduling issues related to participants wishing to maximize their contributions in 2016.

#### Administration

- Third-Party Administrator Request for Proposals: Staff posted the Deferred Compensation Plan TPA RFP on February 5, 2016. The Pre-Proposal Conference is upcoming on February 17, 2016. Staff has also shared this opportunity with the financial industry trade publications Pensions & Investments (P&I) and Financial Investment News. Additionally, the RFP is listed at Onvia (www.onvia.com), which is a subscription notification service many vendors utilize to become informed of government opportunities.
- Staffing: Staff prepared and conducted a selection process through the month of January in order to fill the vacant Benefits Specialist position. Additionally, staff will be working to coordinate a selection process to fill the recently vacated Management Analyst position.

A summary of all completed and upcoming projects for Division staff is provided as Attachment A.

**Meeting Calendar** – Staff maintains a calendar of upcoming Board meetings and proposed topics. This calendar includes the annual meeting plan and will be refined and updated as the Board meets and objectives/assignments are refined for the coming year.
